Doctor of Nursing Practice graduates are eligible to sit for an advanced practice nursing certification exam and become certified in their advanced practice nursing specialty. Certification for the Adult-Gerontology Acute Care Nurse Practitioner is offered through the American Nurses Credentialing Center (ANCC) and through the American Association of Critical Care Nurses. Certification for the Adult-Gerontology Primary Care Nurse Practitioner is offered through the American Nurses Credentialing Center (ANCC) and through the American Academy of Nurse Practitioners (AANP).
